Motion by member Nakamura, seconded by member Evans to approve the transfer of categorical funds to use for flexible categorical programs was approved with member Jackson voting no.

2010-11 Budget

Public hearing and Adoption of the 2010-11 District Budget and Resolution to Certify Fiscal Solvency for the Subsequent Two Years (Attachment A8)

Motion by member Evans, seconded by member Barrera to approve the 2010-11 District Budget and adopt resolution to certify fiscal solvency for subsequent two years failed with members Barrera and Evans voting yes and members de Beck, Jackson, and Nakamura voting no.

Following discussion of the Board, motion by member Evans, seconded by member Barrera to approve the 2010-11 Budget and adopt the resolution to certify fiscal solvency for subsequent two years was approved with members de Beck and Jackson voting no.

Restoration Plan

Resolution Declaring Board Commitment to Develop Budget Restoration Plan (Attachment A9)

Leticia Munguia provided public testimony to the Board regarding the proposed budget reduction restoration plan.

Motion by member Jackson, seconded by member de Beck to direct staff to develop a proposed restoration list for review by the Board. Member Nakamura proposed an amendment to the motion to provide that a flat list would be developed by the Superintendent and Board members would meet to discuss the list and prioritization of the items on the list, died for lack of a second. Following discussion of the Board, the motion was amended to state, adopt resolution declaring the Board's commitment to develop a budget restoration plan was approved unanimously.
